PRESIDENT'S REPORT

SECRETARY'S REPORT

The continued success of the Indoor Cricket Centre must be very pleasing to all members of our Association. In the very near future enough money will be generated through the centre to fulfil an ambition that members of the executive have had since its inception, that being that charges to clubs for the "running" of the association will be the envy of all other Associations.

It is expected that of a number of benefits that members can enjoy, one will be specialised coaching at no cost to clubs or members. Since Lindsay Trollope has taken on the full time organising and management of the centre, it has grown into a well run and profitable venture and we should all be thankful to him for his ability and for the outrageous hours he has put into making the indoor cricket centre a success. There have been many pleasing incidents through out the past season and unfortunately some not so pleasing. Of the "some not so pleasing" the most disappointing is the finals brawl; an incident the likes of which has never been before, and we trust will never happen again. Players who were involved have been suspended for various periods ranging from three matches to a season and a half. To all clubs; be on your guard; if you have a trouble maker in your club make sure he gets the message or get rid of him, he will only bring discredit to your club.

A special thank you to the Umpires of our Association who on a number of occasions were not treated with the respect they deserve. It is the captains responsibility to not only control his players but also to control himself. I therefore request all clubs to be careful who you select as captain of your various grades. Remember it is by his actions that your club will be fielded.

I thank on your behalf, all members of the executive for the time and effort they have put into our Association. I would ask each of the executive members to take home to their wives our appreciation for the co-operation and support they have given you throughout this last season. To our General Secretary Steve Pascoe and Registration Secretary Stuart Newey our heartfelt thanks for a job so very well done. It is with great regret that due to work commitments, Phil McCallum will not be accepting nomination for any cricketing position for this coming season. Phil has been a great worker for our Association over the last 16 years and his duties are too many to list here. Two most notable duties have been (1) in asisting in the formation of the Indoor Cricket Centre and (2) his role in the Cricket Union of Victoria where he has been chairman of the Executive for the last three years. His forthright comments and general assistance on all matters relating to cricket in general and the RDCA in particular will be sadly

To all clubs I wish you well for the coming season in hope that you will play the game for the game's sake.

Elsewhere in this Annual Report, mention has been made of the one most unsavoury incidents that has occurred during the long history of the RDCA.

Whilst justice has been dispensed and the lessons learned from this incident should not be forgotten, I prefer to reflect on the positive aspects of a season which contained many highlights in our mutual pursuit of cricket ideals.

The past decade has seen many changes with new and more challenging projects being undertaken and the past season was no exception.

Appointment of a full time manager to the Indoor Cricket Centre has seen this project progress from an administrative headache to a viable financial asset in less than 12 months. Whilst our original aims of providing club practice facilities and our own special form of indoor cricket have had to be modified to accommodate a "soft ball" version of the indoor competition, the number of teams involved and the income generated more than justifies the decision. Lindsay Trollope can be well satisfied with his endeavours in this regard and member clubs can look forward to obtaining benefits from centre income in the near future.

Affiliation of new clubs into the association does not always proceed without difficulties arising from ignorance of administrative requirements. Not so this year as Templeton CC and (from what I have been told by junior Executive members) Academy CC both conducted their affairs in an exemplary manner. Club executive can be proud of the work they completed during the season as they have set the foundation for what would appear to be potentially successful clubs. Well done to both Clubs.

Efforts of our representative teams during the season was highlighted by our third success in winning the CUOV Under 21 Inter Association Competition. A well balanced team committed to giving their best whenever taking the field certainly deserved the success they gained.

The senior representative teams performances were highlighted by the win over a strong Croydon CC representative team. However, a win against Ferntree Gully DCA remains elusive, much to the chagrin of our President.

Mention must also be made to the magnificent effort of the Ringwood CC in taking off the W.J. Dowling Shield for Under 16 District competition. The majority of members of this team were representatives of RDCA clubs. The way Ringwood CC looked after these lads was nothing short of fantastic. Marion and Bob Giles "adopted" all the boys, who moulded into a champion team with everyone contributing throughout the series. They can all be proud of their efforts which were justly rewarded.

With very few exceptions ground conditions throughout the association appeared to improve considerably and we must thank the various local councils for their endeavours in this regard.

Clubs would be wise to take a lead from North Ringwood CC whose virtual management of the Chandler Shield 1 final series at their ground not only provided top class and hastle free hospitality for the participants but also assisted club finances and went a long way towards securing the finals series for their ground in coming seasons.

In completing my review of last season I must extend my gratitude to all Club secretaries and officials, the R.D.C.A. Executive members, my wife Ann (whose involvement with my RDCA duties is more extensive than many club representatives appear to realise, or appreciate) and my sister, Lynda who assisted so well with the 'phone scores for this season.

The future of the RDCA is exciting and our immediate endeavours will be to review our administrative requirements to alleviate where possible, individuals' time involvement and financial commitment by clubs. An open invitation is extended for any constructive suggestions which will assist in achieving any reduction in this regard.

Good luck to all for season 1984-85.

UMPIRE'S REPORT

Why do those types come along to cricket matches and upset the pleasure of others. We would be very happy for them to stay away in future. The umpires were horrified by the display of behaviour and at this stage I am doubtful whether they will be willing to officiate again at one of our matches.

I can only hope that the people in other Associations and organisations who commented on and queried the lack of control at RDCA matches, also hears of the Investigation Committee's final report

Generally the season was a happy one, umpires doing their best, the majority of Captains controlling their teams thus making the umpire's job so much more pleasant and afterwards reporting on the umpires in a fair manner. It is easy to appoint umpires to such matches, knowing that they will enjoy the experience and assist the game at the same time.

Sadly, we lost one of our colleagues Bob Slape, late in the seaon. A man who was happy to umpire in the lower grades and especially where Juniors were involved. During the RDCA Christmas Carnival he attended on every day at East Ringwood whether appointed to umpire or not and on more than one occasion donned the coat when plans had gone astray. The juniors will miss him just as much as we, on the umpire's panel.

Recruiting was just as difficult as in previous years. Even so, eight "OLD" cricketers joined the panel from various Associations and appeared to be happy with their experiences. Unfortunately seven from the previous season left us, two were unhappy with the pressure exerted by player behaviour, four were affected by shift-work hours change and one couldn't get a leave pass

As usual I appeal to all who read this to introduce me to prospective umpires and then the committee will do the rest, such as introductions, training and assisting them on the field during early matches.

I would like to thank all umpires for their loyal efforts during the year and especially to those who had to change venues at short notice.

INDOOR CRICKET CENTRE REPORT

The 1983/84 year has been one of dramatic change at the Indoor Centre. At the commencement of the year the future of the RDCA maintaining its operation of the centre was in great doubt. It appeared as though a commercial organisation was likely to be given the opportunity of operating the centre as the Association was having difficulty in meeting its commitment to the Shire of Lillydale. However, following protracted discussions with the Shire the Association was given control under the following conditions:

(a) that a full time manager be appointed(b) that the centre would be able to meet all its obligations to the Shire.

As a result I was appointed manager and it soon became obvious that the only way that the second condition could be met was to change the centre from its role as a practice area for local clubs to one which adopted the now widely accepted game of indoor cricket.

After some months of preparation and promotion the indoor competition commenced in February this year and at the time of writing, the centre was operating at maximum usage from 6.30 to 11.00 each night (excluding Saturday). There is also a waiting list of some ten teams for the second season and a number of school teams are using the centre each week.

Financially the centre is now operating successfully and over the next few years it should enable the Association to provide better services for its clubs. While in some respects it is disappointing that the original concept of the Centre needed to be changed it must be stressed that if the Association had not decided to revert to the soft ball style of indoor cricket, the Centre would now be operated by another organisation The centre should be seen as an RDCA asset, rather than an RDCA facility.

SENIOR MATCH COMMITTEE REPORT

Representative teams from the RDCA were quite successful during the 1983-84 season — winning all matches except those against the Ferntree Gully Association. Organised training sessions were very well attended with most players keen to represent their Association. Unfortunately, as in other years, certain selected invitees again turned down offers to repesent the Association.

SENIOR ELEVEN

John Kirby was elected captain of the Senior RDCA Eleven. The side had considerable batting depth and won two of the three games — losing only to Ferntree Gully.

In the first match, a very keen and well disciplined RDCA eleven defeated the Croydon Sub-District side by 72 runs. John Kirby led from the front with both bat and ball making 20 runs and taking 4/40 respectively. Although, Ray Gale's 89 was the match winning innings enabling the RDCA to compile 6/192 off 48 overs. Croydon could only manage 115 in reply with Ray Bent claiming 4/23.

The second match saw Ferntree Gully in all sorts of trouble early in their innings due to some excellent bowling by Paul Sonsie and Stuart Gibb. Ferntree Gully recovered from 5/61 to be dismissed for 159—a target well within reach of the RDCA batsmen. After a confident start, the RDCA bats crashed from 0/22 to be all out for 95. Although the batting was dismal, Paul Sonsie's 3/18 from 13 overs was a just reward for a splendid display of bowling.

In the final game, the RDCA Eleven made heavy work of defeating a very spirited North Suburban side on a hot dusty day at Mutton Reserve. North Suburban made a respectable 4/203 from their allotted 45 overs. However, the result was in the balance until the very end with Ringwood's No. 11 batsman scoring the winning runs in the last over of the day.

UNDER 21 ELEVEN

The RDCA Under 21 Eleven consisted mainly of players from last year's team. The side was particularly strong and well balanced — winning six of the seven games played and losing only to Ferntree Gully.

In the first game of the season, RDCA won a close match against the Ringwood 4th Eleven by 10 runs. After being in trouble early, a fighting partnership between Ashley Lawrence and Chris Baxter enabled the RDCA to reach 6/149. Ringwood managed only 139 in reply.

The Ringwood Under 21 Eleven easily won the CUOV Carnival and during the five CUOV matches, were never at any stage put under pressure. The opening attack of David Jeynes and Doug Pedlar for RDCA always kept opposing batsmen struggling for early runs, while the good batting depth in the side was clearly evident in that the lower order was never required to make runs.

In the first CUOV game against Moorabbin, Richard Sutherland made 64 and Greg Moorehouse took 4/17. Greg Moorehouse contributed again against Sunshine with 62 runs and 3/18 while Peter Hanrahan compiled 64 runs and Cam Milnes captured 3/22. Sutherland and Moorehouse combined again to defeat Federal Districts scoring 59 and 38 respectively.

In the CUOV final against Western Suburbs, RDCA started poorly losing Hanrahan for 0 and Sutherland for 11. However, a whirlwind partnership between Cam Milnes (55 not out) and Captain Lindsay Wolf (35) enabled the RDCA to reach 5/164. With spirited bowling and excellent fielding, the RDCA ensured that Western Suburbs were never in the game and bundled them out for 100 in the 40th over.

Unfortunately, everything went wrong against Ferntree Gully and the RDCA lost this important annual fixture by five wickets

In the final game of the season, the RDCA Eleven easily accounted for the North Suburban Association, compiling 6/282 and routing the opposition for 147. David Jeynes picked up 3/21 and Peter Hanrahan (86), Russell Brodie (39) and Richard Sutherland (74) all contributed with the bat

CRICKET UNION OF VICTORIA DELEGATE'S REPORT

On 8th March 1984 at a Special Meeting called for the purpose the CUOV became an Incorporated Association. This step was in line with action taken by a number of sporting associations to provide protection for elected voluntary officials.

The Union considered a number of applications for grants from the Victorian Cricket Association's Development Fund. It made recommendations to the V.C.A. for grants in excess of \$6,000.00 including two to RDCA Clubs Templeton and Academy. 26 applications have been received for grants in 1984.

As a result of a submission by the CUOV about the shortage of umpires, the VCA has created an Umpires' Recruitment and Training (U.R.A.T.) Committee. It has also provided \$5,000 for costs in 1984/85. The inaugural meeting of the sub-committee was held on 29th March, 1984. It decided that initial activities should be in two areas.—

(a) Development of a manual

(b) Training of umpires who will then train recruits as umpires.

The CUOV is represented on the VCA's Synthetic Surfaces Sub-committee which is looking at synthetic wickets both short-term and long-term with the objective of developing synthetic wickets with desirable turf wicket characteristics. The Sub-Committee has just completed a program of testing all available synthetic surfaces and it is expected that a report of this stage will be completed about the end of this year. This should assist clubs to make decisions on the type of surface available for dollars spent. However, I should give an early warning that clubs should not expect the report to say that product "A" is the best. Each product has its own characteristics and these will be documented. Then clubs will be able to read what they will get for money outlaid.

In 1984, the Union completed a survey of ground rentals and service provided by municipalities throughout Melbourne. These show a wide range of charges by Councils, so wide in fact, it is difficult to categorise them. However, the survey has provided valuable base data which will assist the Union to monitor the position and the effects of the government's "User pays" policy.

The Union has been advised of the intention of the Australian Cricket Board to introduce a new form of modified cricket into Australian schools in September/ October 1984. This modified version will be called "Kanga Cricket" and it has been

tailored to meet the level of physical, mental and skill development of girls and

boys aged six to twelve years.

The Union has asked Associations to consider what services they expect to receive from the Union. In the last two years the Union has experienced difficulty in maintaining progress with some initiatives because they required many hours of work. Therefore the question arises— "Should the Union employ a part-time administrator who would be able to perform these duties?" This would inevitably mean a substantial increase in Association fees unless some arrangement could be reached with the VCA. However, the first important question to be answered is Associations' expectations.

PHIL McCALLUM CUOV DELEGATE

INVESTIGATION/TRIBUNAL CONVENOR'S REPORT

There were two Investigation Committee meetings, one Special Executive Investigation Committee meeting, one Full Executive Investigation Committee meeting, and one Tribunal meeting during the 1983-84 season.

The first meeting of the Investigation Committee had two separate matters to deal with. The first matter dealt with was by a club against an opposing player for misconduct and bad language. Both charges were found proven and the player received a one match suspension on each count to be served concurrently. The second matter also related to charges by a Club against an opposing player, this time for malicious behaviour and bad language. The first charge was found not proven for insufficient evidence but the second charge was proven and the player was reprimanded and required to write a letter of apology to the Club involved and an opposition player.

The second meeting of the Investigation Committee took place after the season had concluded. It dealt with cross complaints by two Clubs in the last home and away match over time wasting, failure to complete the requisite number of overs, language and unsportsmanlike behaviour. The Clubs were directed to be more cognisant with the rules and that the onus was on the captain to ensure that time wasting, unsportsmanlike behaviour and bad language did not occur.

The only Tribunal meeting of the year took place before the commencement of the grand finals and concerned a complaint of misconduct by a Club against an opposition player. The complaint was found proven and the player was severely reprimanded for his conduct with a warning that a return to the Tribunal in the future would result in suspension.

The Executive Investigation Committee meetings were the result of the incidents that took place in the Chandler 3 Grand Final. To avoid a conflict of interest, I was not involved either at Club level or as a member of the Executive in either of these meetings. Spectators and players were involved in a slanging match and melee on the first day of the Grand Final and after a meeting of a Special Executive Investigation Committee and, on subsequent appeal, a Full Executive Investigation Committee, four players (including the Captain from one side) and three spectators from the other received suspensions of varying lengths. As well, both Clubs were placed on \$500 good behaviour bonds for the 1984-85 season.

It appears that Clubs and Captains need to be reminded that it is their responsibility to ensure that both players and spectators are well behaved, that sportsmanship is maintained and that bad language is kept to a minimum. This doesn't mean that the game isn't played hard or that spectators are to be discouraged. What it should mean is that sportsmanship is alive and well and that people are still capable of exercising some commonsense and displaying restraint both on and off the field. If players (and spectators) can exercise some of these aforementioned attributes then there should not need to be a report next year.

Our thanks go to all the members who participated as committee members for their time and efforts.

INCOME AND EXPENDITURE SEASON 1983-84 AT 31/5/84

I have much pleasure in presenting the Balance Sheet for Season 1983-84.

The books were closed at 31st May, in keeping with the requirements of the Registrar Associations Incorporations Act

As can be seen in the Balance Sheet, in spite of increasing costs, the finances of the Association continue to be in a very healthy state. The Secretary was able to purchase the Pennants from another supplier, thus saving the Association \$1000.00. This helped to compensate for increased costs in other areas.

The Association continues to grow each year with our turnover increasing accordingly, but I cannot remember a Season in which so many clubs' finances have been depleted by fines — mostly in Junior Administration.

During the year we loaned the RDCA Indoor Cricket Centre \$6,000 at 10% interest, which is comparable with our investments at the ANZ Bank.

Once again may I offer my thanks to the Treasurers of each club for their cooperation and also my assistant Paul Denton

I would like to pay a special tribute to Park Orchards. They are an inspiration to clubs which may be struggling financially, showing how, with a good, supportive committee, it is possible to develop into a financially strong club.
